<b>SUBJECT:</b> Endorsement of the proposed name to the new road to Juniper Dunes Wilderness Area and adjacent Off-Highway Vehicle (OHV) area.	
<b>FISCAL IMPACT:</b> There are not any costs, other than staff work and effort, associated with preparing the resolution.	
<b>BACKGROUND:</b> On July 29, 2015, the Board of County Commissioners held a public hearing to establish a route known as Alternative 2 to the Juniper Dunes Wilderness Area and adjacent Off-Highway Vehicle (OHV) area. After the public hearing, the Board adopted Resolution 2015-264, establishing the route known as Alternative 2 as a County Road.  The County acquired approximately 4.3 miles of right-of-way from the Bureau of Reclamation (BLM) and private landowners to develop Alternative 2 into a new hard surface road to the Juniper Dunes Wilderness Area/Off-Highway Vehicle (OHV) area.  On October 23, 2018, the Board of County Commissioners entered into a contract with Goodman and Mehlenbacher Enterprises, Inc (GAME, Inc) of Kennewick to construct the new road. Both BLM and Western Federal Lands Highway Division provided grant funding for the construction of the new road.  On July 2, 2019, the new county road has met substantial completion and is open to the public for use. The project is anticipated to meet physical completion in the Fall of 2019.  The new road requires an official recognized name that can be posted on its identity signage and used on County map's location reference materials and County roadlog.  Public Works Department has reviewed names according to the road naming conventions recommends the Board name the new road to Juniper Dunes Drive or Juniper Dunes Road as may please the Board.	
<b>RECOMMENDATION:</b> Adopt the proposed resolution.
