BACKGROUND INFORMATION

HB Painters contract was approved by the Board of Franklin County Commissioners on June 18, 2019. Contract was then scheduled before the Board of Benton County Commissioner's for June 25, 2019.

SUMMARY

The Risk Manager, Paul Schut, with the Benton County Commissioner's Office believed that awarding contract to HB Painters would be a violation of Public Procurement Law and subsequently pulled the contract from the Board of Benton County Commissioner's agenda.

RECOMMENDATION

We recommend that the Board of Franklin County Commissioner's rescind Franklin County Resolution No. 2019-198 between HB Painters and the Benton-Franklin Counties Juvenile Justice Center.
